WHEREAS, the State Adopted Budgets of 2008-2009 and 2009-2010 (SBX3 4) provide "flexibility" for the use of certain Categorical Program Funds to be used in response to the State fiscal crisis, and

WHEREAS, the Flexibility legislation requires the Governing Board, at a regularly scheduled open public hearing, to take testimony from the public and shall discuss and approve or disapprove the proposed use of funding, and

WHEREAS, the attached schedule reflects the estimated amount of Flexibility Funds to be used in the General Fund for an educational purpose as reflected in the various budgets which has been adopted by the Board for the 2009-10 fiscal year,

NOW THEREFORE, BE IT RESOLVED AND ORDERED, the Placentia – Yorba Linda Unified School District Board of Education approves the use of the Flexibility Funds as required by the Budget Act of 2009.

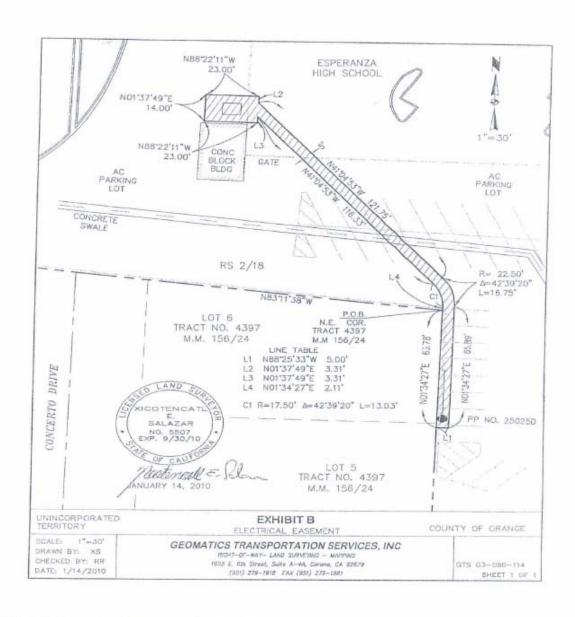
