RESOLUTION FOR THE BOARD OF EDUCATION OF PLACENTIA-YORBA LINDA UNIFIED SCHOOL DISTRICT ACTING AS THE LEGISLATIVE BODY OF THE COMMUNITY FACILITIES DISTRICT NO. 1 AUTHORIZING AND PROVIDING FOR THE LEVYING OF SPECIAL TAXES FOR COMMUNITY FACILITIES DISTRICT NO. 1

WHEREAS, the Board of Education of Placentia-Yorba Linda Unified School District (the "Board") has heretofore taken proceedings pursuant to the Mello-Roos Community Facilities Act of 1982, as amended, (the "Act") for the establishment of Community Facilities District No. 1 (the "District") for the purpose of providing educational facilities for the use of residents of the District; and

WHEREAS, following a special election of the qualified electors of the District, this Board on November 12, 2002 acting as the governing body of the District, adopted Ordinance No. 1 ("Ordinance") which provided for the levying and collection of Special Taxes within the District, "as provided in the Act and Ordinance and as approved by the qualified electors"; and

WHEREAS, it is now necessary and appropriate that this Board levy and collect the Special Taxes for Fiscal Year 2010-2011, by the adoption of a resolution as specified by the Act and Ordinance:

NOW, THEREFORE, IT IS HEREBY ORDERED AS FOLLOWS:

Section 1. In accordance with the Act and Ordinance, there is hereby levied upon all properties within the District which are not otherwise exempt from taxation under the Act or Ordinance the special taxes for Fiscal Year 2010-2011 set forth in the Ordinance at the tax rates as set forth therein and in Exhibit "A" hereto, as may be amended without further action of the Board to reflect updated information on assessor's parcel numbers from the County of Orange. The Assistant Superintendent, Administrative Services, is hereby authorized and directed to establish the final rates to be levied, which final rates shall not exceed the maximum rates.

Section 2. The above-authorized special taxes shall be collected in the same manner as ad valorem property taxes on the secured roll by the Treasurer-Tax Collector of the County of Orange and shall be subject to the same penalties and the same procedure and sale in cases of delinquency as provided for such ad valorem taxes.

<u>Section 3.</u> The Clerk and Assistant Superintendent, Administrative Services, are hereby authorized to transmit a certified copy of this Resolution to the Orange County Assessor and the Treasurer-Tax Collector, together with other supporting documentation as may be required in order to place said special taxes on the secured property tax roll for the Fiscal Year 2010-2011 and to perform all other acts which are required by the Act, Ordinance or by-law in order to accomplish the purpose of this Resolution.

SALE AND DISPOSAL OF EQUIPMENT, BOOKS, AND SUPPLIES

When any district-owned instructional materials, equipment, supplies or other personal property becomes unusable, obsolete or no longer needed, the Superintendent or designee shall notify the Governing Board, provide an estimated value and recommend whether the items be sold or disposed of by one of the methods prescribed in law and administrative regulation. Upon approval by the Board, the Superintendent or designee shall arrange for the sale or disposal of these items.

Instructional materials may be considered obsolete or unusable when they:

- 1. Have been replaced by more recent editions or new materials selected by the Board and have no foreseeable value in other instructional areas
- 2. Are not aligned with the district's academic standards or course of study
- 3. Contain information rendered inaccurate or incomplete by new research or technologies
- 4. Contain demeaning, stereotyping or patronizing references to any group of persons protected against discrimination by law or Board policy
- 5. Are damaged beyond use or repair

The Superintendent or designee shall establish procedures to be used when selling equipment for which the federal government has a right to receive all or part of the proceeds. These procedures shall ensure a reasonable amount of competition so as to result in the highest possible revenue.

Any permanent employee in the classified service shall be subject to disciplinary action and/or dismissal only for cause in accordance with law, and collective bargaining agreements, Board policy, and administrative regulations.

The Superintendent shall develop the necessary administrative regulations to implement the provisions of this policy, including informing the employee by written notice of the specific charges and his/her rights to a hearing.

The Board's determination of the sufficiency of the cause for disciplinary action shall be conclusive.

CERTIFICATED: DISMISSAL/DISCIPLINARY ACTION

The Board of Education expects that all certificated employees exhibit professional and appropriate conduct and serve as positive role models. Unacceptable conduct shall be subject to disciplinary action in accordance with law, collective bargaining agreements, Board policy, and administrative regulation.

Permanent Employees

Permanent employees shall not be dismissed from their position except when cause for dismissal can be shown. Causes and procedures for dismissal are defined by provisions of Education Code Sections 44932 et. seq.

Probationary Employees

During the school year certificated probationary employees may be dismissed for causes specified in Education Code Section 44932 or for unsatisfactory performance determined pursuant to Education Code Sections 44660-44665.

The time limits for initiating such an action and other procedures to be followed are set forth in Education Code Section 44948.3.

At the end of the school year, the Governing Board may decide not to rehire probationary employees without a statement of reasons, giving notice in accordance with Education Code 44929.21. In the case of second year probationary employees, written notice of termination must be given to the employee on or before March 15 of their second year.

Non Performance of Duties

Whenever an employee refuses to perform assigned work without an acceptable reason, the Superintendent or designee shall deduct from his/her wages an amount reasonably related to the time not worked.

RELEASE FROM CONTRACT

Teachers desiring to be released from their teaching contract to accept a position in another school districts should realize that in many instances this creates a severe hardship on the local school district. In arriving at a decision to request a release, a teacher should make every effort to consider the welfare of the students, as well as their own.

In no event will a teacher be released from a contract after August 1 of any given year, except for unusual or extenuating circumstances as well as availability of an acceptable replacement. In the event a certificated employee refuses, without good cause, to fulfill a valid employment contract or leaves the district's service without the consent of the Superintendent or designee, the Commission on Teacher Credentialing shall be notified as prescribed by law.

EMPLOYEE/STUDENT NON-FRATERNIZATION

The relationship between the school employee and the student should be one of professional cooperation and respect. All employees, whether certificated or classified, have a responsibility to conduct themselves in a manner that will maintain an atmosphere conducive to learning.

It is the policy of the Board of Education to support the development of positive relationships between and among students and employees. To that end, district_employees are prohibited from engaging in a relationship with an enrolled student that may be reasonably perceived as unprofessional. This includes excessive personal attention or socializing outside of school, dating, courtship or spending an inordinate amount of time with students as to create the impression to other students, their parents, or the public that a dating relationship exists.

It is also the policy of the Board of Education to prohibit any type of sexual relationship, sexual contact or sexually-nuanced behavior between a district employee and an enrolled student. This includes internet chat rooms, social networking sites, text messages, cell phones, and all other forms of electronic and non-electronic communication that may be viewed as inappropriate. It also applies regardless if the student or the employee initiated the sexual behavior or if the student welcomes the sexual behavior and/or reciprocates the attention.

The District shall promptly investigate all reasonable allegations of prohibited staff/student relationships. The District shall utilize the investigation procedures followed for complaints of sexual harassment within the District.

Any employee who is found to have violated this policy will be subject to disciplinary action up to and including termination.

There may be circumstances that do not involve dating or courtship, but are nevertheless unprofessional. Those cases will be judged on the totality of the circumstances under the causes for discipline set forth in the Education Code and collective bargaining agreements.
